Being fully aware that participation in NPRA sanctioned rodeos will expose said member or permit holder to substantial and serious risk or property damage an/or personal injury or death, said member or permit holder hereby releases the NPRA, NPRA sponsors, any NPRA sanctioned rodeo production entity, their affiliated, related or subsidiary companies, and the officers, directors, employees, and agents of each entity or organization from liability for any and all property damage, personal injuries or other claims arising from participation in NPRA sanctioned rodeos, including claims that are know and unknown, foreseen and unforeseen, future or contingent. NPRA members and permit holders shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, actions, claims and demands hereby waived, released or discharged by NPRA member or permit holder. This provision shall be binding upon each NPRA member or permit holder, his/her spouse, legal representatives, heirs, successors, and assigns.
